Thank you for entering Car-Dun-Al's agility trial. This trial is being held at the club's facility, 10783 Wolf Drive, Huntley, IL. The training center is in the southwest corner of the second building to the west. RVs are allowed only during trial hours on the south side of the building and parking lot along the grassy area of the driveway. They must overnight at one of the local RV parks. Check if they will accept your breed. (Chicago Northwest KOA at 815-923-4206 or Lehman's Lakeside RV at 815-923-4533). In case of emergency, you may contact the secretary the weekend of the trial, call (847)571-5222

The building will not open until 6:45 a.m. **PLEASE** do not come any earlier than this. Exhibitors with dogs who bark in vehicles must either crate their dogs inside or park between the buildings. DO NOT leave barking dogs in vehicles parked to the west of the building. DO NOT use the parking spots in front of the neighboring gymnastic club. Do not walk/potty dogs along the fence on the west side of the drainage area.

ANYONE NOT FOLLOWING THE ABOVE RULES WILL BE ASKED TO LEAVE WITH NO REFUND OF ENTRY FEES.

- 1. Any water on the mats must be cleaned up immediately with the vinegar water solution.
- 2. Use chalk to make marks on the mats. When done, please clean with the vinegar solution.
- 3. There will be no dragging equipment or tables across the floor. Please use the wheeled carts to move things that cannot be picked up.
- 4. Crating.. All wire crates and X pens must have protection under them
- 5. Make sure tables and chairs have rubber protectors on the feet when sitting on the floor.

Agility Gate will be used at this trial so this is the code for all 3 days 60142

Except for the first class of the day in each ring, all start times are approximate. Numbers in each class/jump height are preliminary, and may change based on move ups received or dogs moving off the waiting list. Dogs in the "B" classes will run first, followed by dogs in the "A" classes for each jump height. Dogs in the Preferred program will run after dogs in the Regular program in their corresponding jump height and division.

ARMBANDS; There will be AKC Volunteer Measuring Official at this trial. Any exhibitor who does not have a valid height card needs to be measured before running.

.All exhibitors must check in using agility gate or with the gate steward for their class.

DIRECTIONS: From the East or West on I-90: Exit route 47 (electronic I-Pass only) Go North on Route 47 approximately 3.7 miles to Oakcrest Dr. and turn Left (known as Algonquin Rd to the Right) Go less than .1 miles on Oakcrest to Wolf Drive and turn Left into industrial complex. Take 1st Right drive to back then turn Left. The trial is at the far end of the buildings. GPS coordinates N 42.10.454 W 088.26.040.
